PROHIBITION OF REBATES

Section 41, of Insurance Act 1938

No peson shall allow or offer to allow, either directly or indirectly as an inducement to any person to take out or renew or continue insurance in respect of any kind of risk resisting to lives or properly in India any rebate or the whole or part of the commission payable or any rebate, of the premium shown on the policy not shall any person taking out or renewing or continuing a policy accept rebate except such rebate as may be allowed in accordance with the published prospectus or tables of the Insurer.

Any person making default in complying with the provisions of this section shall be punishable with fine which may extend to five
